End-of-Life Directives for Catholic Physicians

In our last meeting, Ellen Dorn JD explained the end-of-life documentation that was created for our diocese by the St. Thomas Moore society at the request of Bishop Farrell. A standard, Texas Statutory Directive to Physicians currently exists that can be used by Texas citizens as documentation for end-of-life directives. However, a major moral issue with the document is that it includes hydration and nutrition as "artificial life sustaining support" that could be withdrawn if the patient has a "terminal condition" that "according to reasonable medical judgement will produce death."

So the St. Thomas Moore society created a Catholic Advance Directive to Physicians with certain variations to common advanced directives, such as the Texas Statutory Directive. For instance, there is a general directive that "those making decisions on my behalf be guided by the moral teachings of the Catholic Church....and to consult my priest, my bishop, and/or the National Catholic Bioethics Center." It also has a general directive that "Nutrition and hydration may not be withheld or withdrawn from me for the purpose of...hastening death." Another variation is that life sustaining treatment not be withdrawn during pregnancy.

A medical power of attorney also was created and in the language of the document, there is a statement that those making decisions on care of a patient be directed/guided by the moral teachings of the Catholic Church and to consult a priest, the bishop, or the National Catholic Bioethics Center if necessary.
