

food, even when provided by artificial means, always represents a natural means of preserving life, not a medical act. Its use, furthermore, should be considered, in principle, ordinary and proportionate, and as such morally obligatory, insofar as and until it is seen to have attained its proper finality."

The Congregation of the Doctrine of the Faith set another "parameter" when it stated in an August 2007 document, <u>Commentary on Responses to Certain Questions Regarding Artificial Nutrition and Hydration</u>: "When stating that the administration of food and water is morally obligatory in principle...the possibility is not absolutely excluded that, in some rare cases, artificial nourishment and hydration may be excessively burdensome for the patient or may cause significant physical discomfort, for example resulting from complications in the use of the means employed."

So in the meeting Msgr. Olson of Holy Trinity Seminary discussed the article, shared his own opinions on the topic, and the participating physicians had a discussion probing the moral parameters established by Church teaching and its clinical implications in patient care.

The Society for Fertility Awareness Education begins at UTSW

This fall a medical student group at the University of Texas Southwestern Medical School was created to bring proper education of fertility awareness based methods to an academic setting. It plans to train students to be instructors in natural family planning, conduct research studies, train patients and families in the methods, host a speaker series on campus, affect awareness

on campus and its curriculum, and provide scholarships for student rotations with NFP-only physicians. With controversy over artificial contraception heavily on the public radar, the group aims to make this alternative to family planning known so that it may hold a proper place in medical education. Considering its short and long-term programming, there is a large expected annual budget.
