

Please offer input into AMA's stance on Physician Assisted Suicide

At the National AMA meeting this year (June 8-12), the AMA's House of Delegates will once again be voting on assisted suicide, specifically to affirm the slightly revised Council on Ethics and Judicial Affairs (CEJA) report that retains the AMA's longstanding opposition to assisted suicide. Please consider offering input into the process.

If you are a delegate and will be attending, you can speak and vote on this issue. Those not attending the conference can comment at the online forum on the AMA website to express support of the CEJA report. To comment, click on this <u>link</u> and then scroll down to the "Online Forums" section.

In the second box titled "Committee on Amendments to Constitution and Bylaws," click on "CEJA reports."

Then click of the topic "Physician-Assisted Suicide," and you will be prompted to sign in or create a new account. You can then comment on the issue.
