## Next meeting: The Principle of Double Effect Location: ST. THOMAS AQUINAS (NOT ST. RITA)



Is abortion ever morally just? Is prescription of contraceptives ever acceptable? What principals can guide us in these ethically-difficult clinical situations?

The Stanford Encylopedia of Philosophy defines the Principle of Double Effect as "the doctrine (that) is often invoked to explain the permissibility of an action that causes serious harm, such as the death of a human being, as a side effect of promoting some good end." Many of our ideas concerning this principle were first introduced by St. Thomas Aquinas in <u>Summa Theologica</u> and were further elucidated in later Church teachings such as <u>Veritatis Splendor</u> by St. John Paul II. The Church has blessed us with specific guidelines we can use to reason whether certain actions can be morally acceptable in unclear situations.

## Catholic Medical Association statement on the Hobby Lobby decision

The Catholic Medical Association welcomes the Supreme Court's decision in <u>Burwell et al. v.</u> <u>Hobby Lobby</u>. Once again, the Supreme Court has curtailed the Obama administration's abuse of executive power and <u>unprecedented attacks on religious liberty</u>.

At the heart of the Hobby Lobby and related cases is the right of Americans to live and work according to their beliefs without fear of government punishment. Americans should never be forced to surrender their religious beliefs when opening a business. The Supreme Court upheld that principle today.

The Catholic Medical Association was particularly gratified by this decision since it filed an *amicus curiae* <u>brief in this case in conjunction with the Becket Fund</u>, refuting the claim that a new human life begins at implantation and clarifying the fact that existing federal laws protect parties such as Hobby Lobby and Conestoga Woods from discrimination based on their opposition to abortion.
